Subject:-Grant of Conditional Permission to Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurveda, 64/6 Civil Lines, Roorkee-247667, District, Haridwar, Uttarakhand, (AYU0320) with 60 seats in UG (BAMS) course and 11 seats in 02 PG courses in the subject namely (i) Kayachikitsa- 06 seats and (ii) Shalya Tantra- 05 seats for the academic session 2023-24 under section 28 of NCISM Act, 2020 and relevant regulations thereunder-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

1. Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely **to Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurveda, 64/6 Civil Lines, Roorkee-247667, District, Haridwar, Uttarakhand, (AYU0320)** inspection of your College was conducted on **18.05.2023 and 19.05.2023 on Hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process the **Conditional permission with 60 seats in UG (BAMS) course and 11 seats in 02 PG courses in the subject namely (i) Kayachikitsa- 06 seats and (ii) Shalya Tantra- 05 seats for the academic session 2023-24 under Section 28 of NCISM Act, 2020.**
2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", "Indian Medicine Central Council (Post-graduate Ayurveda Education) Regulations 2016", provisions under the NCISM Act, 2020 and relevant Regulations there under.
3. Further, one faculty of your institution in the academic year 2022-23 were proven to be physically absent but working only on paper teacher and in accordance with section 28(1)(f) of NCISM Act 2020, regulation 3(1)(f) of RMS, 2016 as per the letter of MARBISM vide letter no 26-75/2021-visitation dated 31/8/2021 and letter no. 3/2022/MARB/General Matter dated 17/8/22, **a penalty of rupees 25 lakh** was imposed on your institution as **one faculty namely Dr. Gargi Kadyan (AYAT00568)** were proven to be physically not present but working only on paper teachers and same was communicated to you vide letter no. Teacher Verification/MARB/2023 dated 17.03.2023.

4. Further, a **reminder letter was sent to you vide letter of even no. dated 26.07.2023** for remittance of the imposed monetary penalty of Rs. 25 Lakh as one of your faculty as mentioned above were proven to be physically absent but working only on paper.
5. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report of the academic year 2023-24 was placed in the **54th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held **on 22.08.2023**. Board discussed and decided to withhold the permission process till the remittance of the imposed monetary penalty of Rs. 25 lakh.
6. In response of the same you have furnished the imposed penalty amount **worth Rupees 25 lakh** in favour of The National Commission fund for Indian System of Medicine through RTGS vide **UTR No. HDFCR52023091487722661 dated 14.09.2023 from HDFC Bank, Uttarakhand and informed the same vide an email dated 14.09.2023 enclosing a letter vide ref. no. QIA/QA-196/2023/595 dated 14.09.2023**.
7. Therefore, **Grant of conditional permission is issued to Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurveda, 64/6 Civil Lines, Roorkee-247667, District, Haridwar, Uttarakhand, (AYU0320) with 60 seats in UG (BAMS) course and 11 seats in 02 PG courses in the subject namely (i) Kayachikitsa- 06 seats and (ii) Shalya Tantra- 05 seats for the academic session 2023-24 under section 28 of NCISM Act, 2020** subject to the condition that college is fulfilling the following requirements: -
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of **60 seats** and 15% of post-graduate seats of the permitted intake capacity of **11 seats in 02 PG courses** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
 - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no.BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
9. Further, **as per Sub-section (7) of Section 29 of NCISM Act, 2020**, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then **in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.**
10. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
11. **The following requirements should be fulfilled by the college by 31st December, 2023 and compliance report should be sent to get permission for the academic session 2024-25:**

- i) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - ii) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - iii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - iv) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.

3. In view of the above, as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **68th Board Meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **02.11.2023**. Board discussed the same and recommended to **issue letter of Permission to start 02 new PG course with 10 seats in the subject namely (i) Rachna Sharir- 05 seats (ii) Ayurveda Samhita and Siddhant- 05 seats from academic session 2023-24 under section 29 of NCISM Act, 2020**.
4. Further, in accordance of the regulation 6(2)(i)(i) of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019 vide letter of even no. dated **03.11.2023 a letter was sent to you** to furnish fixed security deposit worth **Rupees One Crore Only (Rs.1,00,00,000)** in favor of National Commission fund for Indian system of Medicine for the period of three years. In response of the same you have furnished the fixed security deposit

in favor of the National Commission fund for Indian system of Medicine through RTGS/NEFT/UTR. No. **HDFCR52023110351097088** dated **03.11.2023** of **Rupees One Crore Only (Rs.1,00,00,000)** transferred by **HDFC Bank, Roorkee, Uttarakhand** (for a period of three years) and informed the same vide letter no. **QIA/QA-245/2023/741** dated **03.11.2023**.
