Subject:- Grant of Conditional permission to the Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurved, 64/6 Civil Lines, Roorkee-247667, Distt. Haridwar, Uttarakhand (Inst. Id-AYU0320) for intake capacity with 60 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2022-23 and issuance of Letter of Permission (LoP) to Start 02 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Shalya Tantra-05 seats & Denial of Letter of Permission (LoP) to start 03 new PG courses in the subject namely (i) Ayurved Samhita & Siddhant-05 seats (ii) Rachna Sharir-05 seats (iii) Rog Nidan avum Vikriti Vigyan-06 seats under section 29 of NCISM Act, 2020 from the academic session 2022-23-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

- 1. I am to refer to your application vide ref. no. QIA/QA-177/2021/557 dated 28.10.2021, on the subject cited above and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available at your college namely Quadra Institute of Ayurved, 64/6 Civil Lines, Roorkee-247667, Distt. Haridwar, Uttarakhand (Inst. Id-AYU0320) to start 05 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Ayurved Samhita & Siddhant-05 seats (iii) Rachna Sharir-05 seats (iv) Shalya Tantra-05 seats (v) Rog Nidan avum Vikriti Vigyan-06 seats from the academic session 2022-23, visitation has been carried out for issuance of Letter of Intent on 19.05.2022 & 20.05.2022 through hybrid mode by the visitation team of Medical Assessment and Rating Board (NCISM) and Letter of Intent (LoI) has been issued to your college vide letter of even no. dated 26.09.2022 to start 05 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Ayurved Samhita & Siddhant-05 seats (iii) Rachna Sharir-05 seats (iv) Shalya Tantra-05 seats (v) Rog Nidan avum Vikriti Vigyan-06 seats under section 29 of NCISM Act 2020 from the academic session 2022-23.
- 2. The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the college again on 01.11.2022 and 02.11.2022 through Hybrid mode to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities available as a part of annual visitation for issuance of conditional permission for intake capacity with 60 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2022-23 and Letter of Permission to start 05 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Ayurved Samhita & Siddhant-05 seats (iii) Rachna Sharir-05 seats (iv) Shalya Tantra-05 seats (v) Rog Nidan avum Vikriti Vigyan-06 seats under section 29 of NCISM Act 2020 from the academic session 2022-23.
- 3. Further, in view of above assessment report and all other related documents were assessed in terms of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016",the "Indian Medicine Central Council (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" provisions under the NCISM Act, 2020 and relevant Regulations there under, visitor's report and on the basis of Relaxation policy issued by the NCISM dated 16.03.2022. On examining the same certain deficiencies were observed by the Medical Assessment and Rating Board for Indian System of Medicine (NCISM).

- **4.** As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the **18**th **Board Meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **17.11.2022**. On careful examination of the assessment report Board decided to provide an opportunity of hearing to your college. Thereafter, an opportunity of hearing was granted to your college **on 22.11.2022** to present the case through virtual mode.
- 5. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM has been carefully re-examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant regulations there under, and was once again placed in 21st Board Meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) dated 29.11.2022.
- 6. In view of the observation of Hearing Committee based on the submission made by the college representatives during hearing and assessment report has been carefully examined in terms of concerned Regulation and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and it is found that the college could not provide sufficient documents/evidence to substantiate the claims to fulfill the shortcomings as informed vide MARBISM letter (Hearing notice) of even no. dated 17.11.2022 and college is fulfilling the basic eligibility criteria for Grant of Conditional Permission, to Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurved, 64/6 Civil Lines, Roorkee-247667, Distt. Haridwar, Uttarakhand (Inst. Id-AYU0320) with 60 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2022-23, issuance of Letter of Permission (LoP) to Start 02 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Shalya Tantra-05 seats under section 29 of NCISM Act 2020 from the academic session 2022-23 and not fulfilling the basic eligibility criteria for issuance of Letter of Permission (LoP) to start new PG courses in the subject namely (i) Ayurved Samhita & Siddhant-05 seats (iii) Rachna Sharir-05 seats (iii) Rog Nidan avum Vikriti Vigyan-06 seats due to following reason-

As per sub regulation (7) of Regulation 6 of PG MSR Ayurveda 2016, The minimum additional teaching staff required for starting post-graduate course shall be one Professor or Reader and one Lecturer of the concerned subject, in addition to the teachers stipulated for under-graduate teaching, and the specialty which does not exist as independent department at under-graduate level shall have minimum one Professor or Reader and one Lecturer for starting post-graduate course.

However, there is no additional higher faculty (Professor/Reader) in each of the Department of (i) Ayurved Samhita & Siddhant (iii) Rachna Sharir (iii) Rog Nidan avum Vikriti Vigyan for PG against the minimum requirement of 01 professor in concerned subject as per sub regulation (8) of regulation 6 of.

- 7. Further, in accordance of the regulation 6 (2) (i) (i) of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019 vide letter of even no. dated 30.11.2022 a letter was sent to the college to furnish fixed security deposit worth Rs. 1 crore (50 lakh per speciality) in favor of National Commission fund for Indian system of Medicine for the period of three years, in response of the same college has furnished the fixed security deposit in favor of the National Commission fund for Indian system of Medicine through RTGS/NEFT/UTR. No. HDFCR52022120264634688 dated 02.12.2022 of Rs. 1 crore (50 lakh per speciality) transferred by HDFC Bank, Roorkee (for a period of three years).
- 8. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) to issue Conditional Permission for intake capacity with 60 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2022-23, to issue Letter of Permission (LOP) to The Principal, Chaudhary Harchand Singh Atmaram Education Trust, Quadra Institute of Ayurved, 64/6 Civil Lines, Roorkee-247667, Distt. Haridwar, Uttarakhand (Inst. Id-AYU0320) to Start 02 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Shalya Tantra-05 seats under section 29 of NCISM Act 2020 from the academic session 2022-23 and Denial of Letter of Permission (LoP) to start 03 new PG courses in the subject namely (i) Ayurved Samhita & Siddhant-05 seats (ii) Rachna Sharir-05 seats (iii) Rog Nidan avum Vikriti Vigyan-06 seats under section 29 of NCISM Act, 2020 from the academic session 2022-23 and relevant regulations thereunder and subject to following conditions:
 - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
 - II. It is further informed that minimum 15% of undergraduate seats of the **permitted intake capacity of 60 seats and 11 seats in 2 PG courses** shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2022-23 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted there under.**
 - III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.

- Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations there under
- 10. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 11. The following requirements should be fulfilled by the college by 31st December, 2022 and send a compliance report to get permission for the session 2023-24:
 - all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;

all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);

iii) all the requirements of the "Indian Medicine Central Council (Requirements of Minimum Standard for Postgraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;

all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made there under should be fulfilled in toto; and

- 12. The permission to Start 02 new P.G. Ayurveda courses in the subject namely (i) Kayachikitsa-06 seats (ii) Shalya Tantra-05 seats from the academic session 2022-23 as stated above for the first admitted batch of 2022-23 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act, 2020.
- 13. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
